

## AMPA Scholarship Campaign

## **TERMS & CONDITIONS**

The AMPA Scholarship Campaign ("the Campaign") is organised by the Academy of Music and Performing Arts (AMPA) and commences on 26 August, 2021.

Entry submissions close on 20 September, 2021.

Participation in the Campaign is subject to the below Terms and Conditions.

- 1. Information on how to enter forms part of the Terms of Conditions. Entry into the Campaign is deemed acceptance of these terms and conditions.
- 2. Entry is open to citizens and permanent residents of Australia. Current or former students, employees and their immediate families of AMPA are not eligible to enter.
- 3. The Campaign commences on 26 August, 2021. Entry submissions close on 20 September, 2021.
- 4. The Campaian will be advertised.
- 5. To enter, participants must enter an application form (found at <a href="https://www.ampa.edu.au/index.php/scholarships">https://www.ampa.edu.au/index.php/scholarships</a> and submit a video in accordance with the application guidelines; a 300-word support statement and copies of applicable school/studio/examination certificates and/or awards.
- 6. Participants must be at least 18 by the year of commencement at AMPA. Entrants may enter whilst they are under the age of 18 (provided they will be 18 by the start of their intended intake) however they must obtain the express written consent of a parent or guardian over the age of 18 to do so.
- 7. Incomprehensible and incomplete entries will be deemed invalid.
- 8. Participants in the Campaign may only enter once per person.
- 9. Only one scholarship is available to each participant.
- 10. AMPA reserves the right to verify the validity of entries and to disqualify any entry which, in the opinion of AMPA, includes objectionable content, potentially insulting, inflammatory or defamatory statements, disqualify any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of AMPA, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of AMPA. AMPA reserves the right to disqualify a participant if it becomes aware that the participant and/or the participant's entry is of a type described in this clause.
- 11. AMPA accepts no responsibility for any late, lost or misdirected entries not received by AMPA or delays in the delivery due to technical disruptions, network congestion or for any other reason.
- 12. Scholarships are awarded for tuition fees only, and do not cover any additional enrolment fees, travelling or living costs.
- 13. Scholarships will be awarded as below:
  - 1) MUSIC:
    - a) 1 x 50% based on excellence (cash payment of up to \$13,200 per annum)
    - b) 1 x 30% interstate (cash payment of up to \$7,920 per annum)
    - c) 1 x 20% regional NSW (cash payment of up to \$5,280 per annum)
  - 2) DANCE:
    - a) 1 x 50% based on excellence (cash payment of up to \$13,200 per annum)
    - b) 1 x 30% interstate (cash payment of up to \$7,920 per annum)
    - c) 1 x 20% regional NSW (cash payment of up to \$5,280 per annum)
- 14. The following conditions must be met by scholarship recipients to maintain their scholarship:
  - Maintain a consistently high quality of excellence and demonstrate exemplary personal conduct at all times;
  - b. Achieve a distinguished record of achievement in all classes/subjects (Credit or above for all subjects and Distinction or above for Principal Studu):
  - c. Attend and/or perform at AMPA events where reasonably possible;
  - d. Uphold an attendance record of 80% in all subjects;
  - e. Uphold the reputation of AMPA throughout the full duration of the course and refrain from engagement in any disparaging or defamatory remarks about AMPA or its staff;
  - f. Notify AMPA of any changes in conditions under which the scholarship was granted;
  - g. Not discuss details of scholarships with anyone other than the management at AMPA; and,



- h. Abide by the AMPA Student Code of Conduct at all times.
- 15. Scholarship payments will be made to the recipient's nominated bank account, at the relevant prorata amount, at the end of each trimester completed.
- 16. Scholarships cannot be transferred and are applicable to tuition fees only.
- 17. Unless expressly stated in these terms and conditions all other expenses, such as living expenses, equipment, etc.) remain the responsibility of the scholarship recipient.
- 18. By accepting the scholarship, the recipient agrees to participate in and co-operate as required with all reasonable media editorial requests relating to the prize, including but not limited to, being interviewed, photographed or filmed.
- 19. In consideration for AMPA awarding the scholarship to the recipient, the recipient hereby permits the recipient's image and/or voice, as recorded, photographed or filmed to appear in connection with AMPA or the advertising or marketing thereof, in any media whatsoever throughout the world and the winner will not be entitled to any fee for such use.
- 20. In the event that for any reason whatsoever a recipient does not proceed with enrolment at the date stipulated by AMPA, then the scholarship will be forfeited by the winner.
- 21. Should an entrant's contact details change during the promotional period, it is the entrant's responsibility to notify AMPA. A request to access or modify any information provided in an entry should be directed to AMPA.
- 22. The decision relating to the Campaign is final, and AMPA will not enter into correspondence regarding the Campaign result.
- 23. It is a condition of accepting the scholarship that the recipient must comply with all the terms and conditions outlined.
- 24. It is a condition of accepting the scholarship that the recipient may be required to sign a legal release in a form determined by AMPA in its discretion.
- 25. In the case of the intervention of any outside act, agent or event which prevents or significantly hinders AMPA's ability to proceed with the Campaign on the dates and in the manner described in these terms and conditions, including but not limited to vandalism, power failures, tempests, natural disasters, acts of God, civil unrest, strike, war, act of terrorism, AMPA may in its absolute discretion cancel the Campaign and recommence it from the start on the same conditions, subject to any written directions given under State Regulation.
- 26. AMPA shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury suffered or sustained in connection with any prize except for any liability which cannot be excluded by law. AMPA is not responsible for any incorrect or inaccurate information, either caused by any of the equipment or campaign associated with or utilised in this Campaign, or for any technical error, or any combination thereof that may occur in the course of the administration of this Campaign including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or satellite network failure, theft or destruction or unauthorised access to or alteration of entries
- 27. AMPA reserves the right in its sole discretion to disqualify any individual who AMPA has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. AMPA's legal rights to recover damages or other compensation from such an offender are reserved.
- 28. AMPA and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.
- 29. If for any reason this Campaign is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of AMPA, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, AMPA reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the Campaign, subject to any written direction given under State Regulation.
- 30. All entries become the property of AMPA. AMPA collects personal information about you to enable you to participate in this campaign but no further use of this information will be made without prior consent.
- 31. AMPA is collecting the applicant's personal information for the purpose of conducting and promoting this Campaign (including but not limited to determining the scholarship recipient).
- 32. Scholarship recipients will be chosen by a dedicated scholarship panel. Decisions will be final, and all entrants will be notified of the result of their entry in due course.
